Submission Guidelines

Please observe that abstracts can only be submitted electronically, through the EUROSKIN web site at: www.euroskin.org Deadline for abstract submission is 1 July 2003.

Abstracts must be written in English and the presentations must be given in English.

A valid abstract must contain maximum 2500 characters including spaces and excluding the title and contact information on authors.

Authors should indicate in the space provided the *preferred* type of presentation. The Organising Committee will make all final decisions regarding the type of presentation. Accepted abstracts will be presented in oral and poster sessions. Poster presenters will be asked to be present by their poster during poster session.

References, credits or the authors' academic degrees or grant support are not to be included in the abstract. Standard abbreviations may be employed in the text. Place special or unusual abbreviations in parentheses after the full wording when it appears for the first time in the body of the text.

It is the author's responsibility to submit a correct abstract. The organisers will not correct any errors in spelling, grammar, or scientific fact.



Arrival at Arlanda Airport: Local Transportation

Airport coaches leave Arlanda Airport (Stockholm's international airport) every 5–10 minutes for the City Terminal in central Stockholm. The bus ride takes approximately 35 minutes and costs SEK 80. (March, 2003).

From Arlanda Airport there is a direct train connection to the Stockholm Central Station. The journey takes about 20 minutes, cost SEK 180 (March, 2003). The train leaves every 15 minutes from Arlanda Airport, and is specially designed with extra space for luggage.

Taxis are available outside the arrival hall at Arlanda Airport. Prices may vary considerably, so you are advised to ask for the price before entering the taxi. Many taxi companies offer a fixed price of SEK 350–450 from Arlanda Airport to Stockholm city centre and the driver is obliged to give you a printed receipt on request (March, 2003). We recommend Taxi Stockholm, Taxi Kurir and Taxi 020.

Badges

Each participant will receive a name badge upon registration. For security reasons all participants are requested to wear their badge during all the conference activities and social events.

Banks and Post Offices
